TRIP and TOUR AGREEMENT

- **Deposit:** Initial Deposit due now. Balance as shown on previous page.
- **Cancellation and/or changes:** Chagrin Valley Ski Club reserves the right to withdraw the tour, to refuse to accept or retain any person as a member of the tour at any time, or make changes in the published itinerary whenever in their sole judgment conditions warrant prior to departure time.
- **Waiver:** Each trip participant is required to sign a waiver prior to departure to hold harmless CVSC, the trip operator and the trip Chairpersons.
- **Payments:** Payments are due at the Trip Leader’s address on the dates indicated on the trip form. Deposits will be accepted until the trip is full. When trip is full, your name and deposit will be held on a waiting list until there is an opening or returned depending on your instructions. Payments are due as stated on trip form. If balances are not received by those dates the people on the waiting list will be given priority and you will be considered to have canceled. Your deposit will automatically be forfeited.
- **Membership:** Membership in the Chagrin Valley Ski Club or other CMSC Ski Club is required. CVSC membership is \$20.00 single, \$35 family (or **Event Membership of \$10.00.**)
